Dear Sir/Madame,

The Ministry of Culture and Information Policy of Ukraine informs you that on February 2, 2021 the President of Ukraine Volodymyr Zelenskyu signed the Decree No. 43/2021 "On the Decision of the National Security and Defence Council of Ukraine of February 2, 2021 "On application of personal special economic and other restrictive measures (sanctions)"<sup>1</sup> (attached). This Decree has enacted the above mentioned Decision of the National Security and Defence Council of Ukraine and imposed sanctions against the People's Deputy of Ukraine Taras Kozak, as well as against the TV channels "112 Ukraine" (and its regional broadcasters), NewsOne and Zik that belong to him.

This decision was made on the basis of the Law of Ukraine "On sanctions"<sup>2</sup>, the Law of Ukraine "On combating terrorism"<sup>3</sup> and the Law of Ukraine "On prevention and combating the legalization (laundering) of proceeds of crime, financing of terrorism and financing of the proliferation of weapons of mass destruction"<sup>4</sup>. In particular, the Law of Ukraine "On sanctions" foresees that special economic and other restrictive measures (hereinafter – sanctions) may be applied with the aim of protecting national interests, national security, sovereignty and territorial integrity of Ukraine, to combat terrorism as well as to restore violated rights, freedoms and lawful interests of the Ukrainian citizens, society and the State. The reason for such actions lies, in particular, in these channels' dissemination of the content that threatens national interests, national security, sovereignty and territorial integrity of Ukraine.

According to the YouTube Policies (namely, Violent Criminal Organizations), content intended to praise, promote or aid violent criminal organizations is not allowed on YouTube. These organizations are not allowed to use YouTube for any purpose, including recruitment<sup>5</sup>.

It is also necessary to underline that the U.S. Embassy in Ukraine made a statement and expressed support to Kyiv's actions on counteraction of malicious Russian's influence<sup>6</sup>.

Taking into consideration that content disseminated through the TV channels "112 Ukraine", NewsOne and Zik threatens national interests, national security, sovereignty and territorial integrity of Ukraine as well as promotes terroristic organizations, forbidden in Ukraine, the Ministry of Culture and Information Policy of Ukraine kindly asks you to limit access to the YouTube channels of TV channels "112 Ukraine" (<https://www.youtube.com/user/112Ukraine>), NewsOne (<https://www.youtube.com/channel/UC9oI0Du20oMOlzsLDTQGfug>) and Zik ([https://www.youtube.com/channel/UCUOsDBuiB\\_1zkRixc33TgSg](https://www.youtube.com/channel/UCUOsDBuiB_1zkRixc33TgSg)).

DECREE OF THE PRESIDENT OF UKRAINE N°43/2021

On the decision of the National Security and Defense Council of Ukraine of February 2, 2021 "On the application of personal special economic and other restrictive measures (sanctions)"

In accordance with Article 107 of the Constitution of Ukraine, **I decree:**

1. To put into effect the decision of the National Security and Defense Council of Ukraine of February 2, 2021 "On the application of personal special economic and other restrictive measures (sanctions)" (attached).
2. Control over the implementation of the decision of the National Security and Defense Council of Ukraine, enacted by this Decree, shall be vested in the Secretary of the National Security and Defense Council of Ukraine.
3. This Decree shall enter into force on the day of its publication.

**DECISION**

**of the National Security and Defense Council of Ukraine of  
February 2, 2021 On the application of personal special economic  
and other restrictive measures (sanctions)**

In accordance with Article 5 of the Law of Ukraine "On Sanctions", the National Security and Defense Council of Ukraine **decided:**

1. To support the proposals on the application of personal special economic and other restrictive measures (sanctions) submitted by the Verkhovna Rada of Ukraine (Resolution of the Verkhovna Rada of Ukraine of October 4, 2018 N° 2589 – VIII) and the Security Service of Ukraine.
2. Apply personal special economic and other restrictive measures (sanctions) to:
  - 1) individuals in accordance with Annex 1;

2) legal entities in accordance with Annex 2.

3. Ensuring the implementation and monitoring of the effectiveness of personal special economic and other restrictive measures (sanctions) provided for in paragraph 2 of this decision shall be vested in the Cabinet of Ministers of Ukraine together with the Security Service of Ukraine and the National Bank of Ukraine.

4. The Ministry of Foreign Affairs of Ukraine must inform the competent authorities of the European Union, the United States of America and other states about the application of sanctions and raise the issue of imposing similar restrictive measures by them.
