topic: ICANN - Ukraine meeting in Copenhagen (March 12-13,2017)

Göran Marby ICANN President and CEO Dear Mr. Marby,

Thank you for your answer (October 26, 2016) regarding stakeholder engagement in Eastern Europe and supported by ICANN the first Eastern European DNS Forum that took place in Kyiv (December 2017). It was well organized and successful diversified multi-national meeting. We do hope than the local, international community, and ICANN will support this event in future and Ukraine will have honor to host it. The role of ICANN GSE regional team is vital for this.

Ukrainian stakeholders, fellows and GAC representatives will participative the ICANN58 meeting in Copenhagen. Moreover, Cyrillic Generational Panel, which was created during ICANN51 with strong support of Ukrainian private and government stakeholders, will finalize Proposal for aCyrillic Script Root Zone LGR during panel meeting on March 13. The discussion needs also the Memorandum on Understanding between the State Agency on e-Governance Of Ukraine ICANN (the Draft was submitted to ICANN GSE on March 2016).

We consider ICANN58 meeting as wonderful chance to discuss the latest developments in ICANN – Ukraine cooperation and shape the future goals for as for Commercial, non-Commercial as for Government stakeholders with you and GSE team.

Dear Mr. Marbi,

Please let me present the assurances of my highest consideration and commitment to build further fruitful and lasting cooperation between Ukraine and ICANN, especially chaired by you as a newly elected President and Chief Executive Director.

Taking this opportunity please also let me address to you with the following. European Integration is a priority vector of Ukrainian foreign and domestic policy, which may be evidently seen from wide political and economic reforms agenda we are going through at the moment. Let me also stress that the aggression of the Russian Federation fades away thousands of lives of the best Ukrainians and the price Ukraine is paying for its devotion to prosperity, economic development and saving of the values of all free world is extremely high.

Thus, we kindly call upon ICANN to take following steps which, in our mind, would largely contribute to and affirm the adherence or your organization to recognized principles of international law:

- To change regional assignment of Ukraine from "Central Europe, Russia and Central Asia" to "Europe".
- 2. Ensure that all ICANN actions in relation to changes in the names of capitals, subnational items specified in the ISO 3166 2, other types of names of national titles, applied within the territory of Ukraine, including those of cultural and historical heritage indicated in the UNESCO and UN lists, may not be taken unless by the initiative and consent of Ukraine.

In context of abovementioned let me also inquire about the possibility of exchange of information on possible amendments that were initiated by Russian Federation, in order we could jointly build a uniform position based on respect to principles of sovereign equality, inviolability of frontiers and territorial integrity of a state as it's laid down in the Final Act of the Conference on Security And Co-Operation in Europe, held in Helsinki in 1975.

Finally, let me stress on our sincerest commitment to the principles of multistakeholodering and protection of human rights in Internet and kindly suggest for your consideration our proposal to hold ICANN63 meeting, planned for

October 2018, in Kyiv, Ukraine.

Please let me renew to you, Mr. Marbi, the assurances of my highest consideration and readiness for practical dialogue between our sides on issues specified above, as well as on any other issues of common interest.
